Official Opening of Games Wall

The Multi Games Wall in the King George V playing field was officially opened on the 3rd at the beginning of this month. Amongst those Brookvale joining local residents to mark occasion were Mayor Marilyn Tucker, Andrew Hunter MP, Fred Kirkland the National Playing **Fields** Association (NPFA) and representatives Basingstoke & Deane BC, Basingstoke Town Football Club and Grosvenor Holdings, the sponsors of the wall.


Fred Kirkland, of the NPFA. opened proceedings. "The NPFA was founded 75 years ago to protect. acquire develop playing fields and recreational areas for young people. The work we do today is just as important as the work we did in the days of King George V who bequeathed this field to the NPFA in order to protect it for eternity. This new games wall initiative is something that we are introducing to a selection of

our playing fields over the country - they allow children to play ball rebound games up against it."

Top: Local officials gather with Brookvale residents for opening Left: Plaque unveiled Right: Children enjoy the new Games Wall


Wall Opens

Bernard Ferris of Grosvenor Holdings said they were "absolutely delighted to help finance the building of the wall." Grosvenor are relatively new to the town and they "hope to be doing many more community projects such as these".

Mayor Tucker thanked everyone in attendance and expressed her gratitude to the BCA who had been involved in the consultation process of the building work. She also said that she hoped "all villages would have such facilities in the future". Andrew Hunter MP echoed the Mayor's wishes for the future.

A plaque was then unveiled by Mr Hunter, Mayor Tucker and Jason Bristow, a representative from Basingstoke Town FC. Just before the rain set in washing away the beautiful weather we had been experiencing all afternoon, there was time for a photo shoot with the Basingstoke Observer and our own photographer for Blurb. Children from a Summer Fun Scheme organised by the Basingstoke YMCA then spent the next half an hour or so enjoying the new facility. presentation was made later on that afternoon by the NPFA at The Anvil.



Renovation work has now started on the Village Hall in Lower Brook Street. We're going to keep you up-to-date on what A&E, the builders, are doing...

So far this month:

- A container was delivered and the contents of the hall were moved into it for the duration of the renovations.
- The ashes and charred timbers were cleared into a skip - this was a dirty job!
- Next, the smoke blackened ceilings, melted lights and cabling were torn
- The remaining annex roof timbers and tiles have been removed and the walls have been demolished.
- Clearing of the remainder of the building has been started.

Highlights of Minutes - BCA Management Meeting - 19th July 2000

- Cllrs John Shaw and Lynden Jones were present.
- The Council and the Developers have at last realised that the information provided to them from the BCA regarding Victory Roundabout is true. The BCA advised the council that the water table in this area was too high and would cause flooding if the roundabout was developed. Hopefully they will now act.
- Parking restriction amendment along Lower Brook Street from May Street to Victory Green allows for parking bays - 2 in May Street for 4 hours and not returning within 2 hours.
- A survey was proposed to find out what the community expected of BCA plans to continue the parent and toddler group, revive 'Community Care', and provide a Youth Club, Holiday Events for youngsters and Coffee Mornings for older residents.

Conservation order too strict?

In the early 80s the company I worked for relocated to Camberley. I couldn't afford a house in Camberley so instead, we cast our net further afield - further along the M3. We looked at a number of properties in Basingstoke but settled on Brookvale because we liked the character of the street, proximity of the railway station and a small park was close by in which to walk the dog.

The house was a little run down and in need of some investment. We decided that we couldn't afford a house in better condition - we would plump for this one and do the maintenance repair work at our leisure.

Recently, the streets of Brookvale have become a Protected Area. We supported this change to the area. Some of the houses in original condition are very attractive. Unfortunately, many like ours have suffered down the years from so-called improvements. Our windows, like many others on the street, were probably replaced in the 1970s. Very cheap, single glazed aluminium units.

After much saving, we're finally in a position to replace the windows at the front of the house. We did the rear windows some time ago. I knew that in order to do this, I had to contact the council and submit a planning application. I contacted the council for both information and the appropriate application forms. I was immediately advised that I would have to replace the windows with those reflecting the original specifications. In other words, I would have to put back in wooden sash windows. This has not come as a great surprise, and this was my intention. In my view, if you look at the houses on the street that have retained the sash, they are generally more attractive than those with aluminium or replacement PVC windows. I was then provided with a list of suppliers that the council had used in the past. The lady was careful to point out that these were not recommended or endorsed by the council in any way. I guess I had no idea of the cost of such windows. I was later to find, after speaking to a number of suppliers, that I could expect to pay upwards of £7000 just for one bay window and three units upstairs. That was a shock. We didn't have that kind of money available and hadn't ear-marked sufficient funds.

In view of this, I would very much like to consider UPVC sash windows which, from what I have seen so far, are equally attractive and maintenance free. The council, however, insist that only wooden single glazed sash units are acceptable. When I asked about grants, I was advised that they exist, up to a maximum of 20% but in actual fact, there was no money in the pot. Consequently, I am left with a rather unattractive front elevation and despite the fact that even the most basic UPVC windows would be a dramatic improvement and improve the overall look of the house, there's absolutely nothing I can do until I'm able to find twice the amount I had originally

intended to spend.

Whereas I would agree that it would be very nice to have many of the houses looking like they originally did, if you take a look around Brookvale, it's clear to see that significant damage has already been done. I would like to bring back some original features to our home but the cost relative to the overall price of the house is prohibitive. I'm quite sure there are many other people in Brookvale who would not and could not afford to spend this money on replacement windows.
